October 23: Your adventure begins at the **Boise Cole & Emerald Branch**, where we will board the shuttle around **10:00 AM** along with our wine expert and tour guide. **We will be visiting four different wineries than our last “Sips & Giggles Tours” in 2024 and 2025. Two of these wineries might be brand new!** While on tour, we will have an opportunity to taste the different varietals of wines such as Viognier, Malbec, Tempranillo, and much more. Included in your reservation is a personal charcuterie board for lunch/snacking. We will also have many snacks and water onboard the shuttle.

Idaho has a long history of wine production with the first vineyards in the Pacific Northwest being planted here in the 1860s. Like in other areas, Prohibition in the United States virtually wiped out the Idaho wine industry in the early twentieth century, only to have it resurrected again in the 1970s. In 2007, the Snake River Valley American Viticultural Area was created, designating an 8,000-square-mile, federally recognized grape-growing area.



Just 40 minutes from Boise, the Sunnyslope Wine Trail is home to 15+ award-winning wineries, each offering distinct wines, breathtaking vineyard views, and warm Idaho hospitality. Known as the Heart of Idaho Wine Country, this region boasts a growing reputation for producing some of the finest wines in the Pacific Northwest.

After we enjoy our time at the wineries, we will make our way back to the Boise Cole & Emerald Branch, returning in the afternoon, where we will conclude our “Snake River Valley Winery Adventure”.
